

The Council of Europe

The **Council of Europe** is an international organization promoting co-operation between all countries of Europe in the areas of legal standards, human rights, democratic development, the rule of law and cultural co-operation. It has 47 member states with some 800 million citizens, and is an entirely separate body from the European Union (EU), which has only 27 member states. Unlike the EU, the Council of Europe cannot make binding laws. The Council of Europe has nothing to do with either the Council of the European Union or the European Council, which are both EU bodies.

Convention 108 (Council of Europe)

Convention 108 refers to the **Convention for the Protection of Individuals with regard to Automatic Processing of Personal Data** which was adopted by the Council of Europe in 1981. This Convention was the first legally binding international instrument adopted in the field of data protection. A total of 42 European states have ratified the Convention so far. At the same time, the Organization for Economic Co-operation and Development (OECD) issued guidelines to its members, which urged them to introduce measures to protect personal information.

National constitutions

Respect for private life and protection of personal data have been recognised as closely related, but separate fundamental rights in Articles 7 and 8 of the **EU Charter of Fundamental Rights** adopted in 2000 and reaffirmed in 2007. These principles are also reflected in the national constitutions of the member states of Council of Europe.

EU data protection legislation

As a result of the work in the Council of Europe and in the OECD, many European countries had enacted legislation designed to balance the individual's right to data protection with the need of public authorities, employers and others to process data. This was undertaken at national level long before the initiative was taken at EU level in early 1990's to ensure more harmonisation on the basis of Convention 108. Data protection is now highly developed in the EU and reflected in the following legal instruments:



- 1. Directive 95/46/EC ("Data Protection Directive") is the central piece of EU legislation, which regulates the protection of individuals with regard to the processing of personal data and the free movement of such data. As a framework law, the Directive had to be implemented in EU Member States through national laws. The Directive stipulates general rules on the lawfulness of personal data processing and rights of the people whose data are processed ('data subjects'). The Directive also provides that at least one independent supervisory authority in each Member State shall be responsible for monitoring its implementation. It also governs the use of data carriers and information and regulates the processing of personal data regardless of whether such processing is automated or not, stipulating that: a). people are not allowed to process personal data without the consent of the party involved, b). people have the right to access their own data and correct errors, c). data cannot be abused or used without the consent of the person it concerns. Companies working with people in the EU must demonstrate that they have adequate protections in place to secure the data and prevent it from being abused.
- 2. Directive 2002/58/EC ("e-Privacy Directive") is concerned with the processing of personal data and the protection of privacy in the electronic communications sector and regulates areas such as confidentiality, billing and traffic data, rules on spam, etc.
- 3. Regulation (EC) No 45/2001 lays down the same rights and obligations as Data Protection Directive at the level of the EC institutions and bodies. It also establishes the European Data Protection Supervisor (EDPS) (Europäische Datenschutzbeauftragte - EDSB) as independent supervisory authority with the responsibility to monitor the processing of personal data by the EC institutions and bodies.
- 4. Framework Decision 2008/977/JHA on the protection of personal data processed in the framework of police and judicial co-operation in criminal matters. It is a legal framework for data protection in the "third pillar" of the EU. Its content is also based on Convention 108, but differs from Directive 95/46/EC in many ways that are related to the specific nature of the subject.



Specific national legislation

Specific national legislation serves as the basis for the activities provided by REISSWOLF. In Germany, this is the latest version of the Federal Data Protection Act (BDSG). Federal Data Protection authorities where REISSWOLF is registered must carry out checks at REISSWOLF etc. Data protection regulations overview (all member states of the Council of Europe) is listed below.

Belarus is not a signatory to the European Convention on Human Rights

Belarus has not signed the Convention 108 for the protection of Individuals with regard to Automatic Processing of Personal Data as well as the Convention's Additional Protocol on supervisory authorities and trans-border data flows.

Belarus does not have special legislation on data protection. In May 2009 the Law on Information, Informatization and protection of information entered in force. According to Article 32 of the law "transfer of personal data shall be allowed only on the basis of consent of the person this information relates to, or according to the legislation of the Republic of Belarus. (...) If personal data has been received with violations of these requirements (...), a party that has obtained such information shall not be entitled to use it and is bearing responsibility in accordance with the legislation of the Republic of Belarus". But the law does not establish a data protection authority nor does it say about a governmental body responsible for data protection.

Kazakhstan has not signed the Convention 108 for the protection of Individuals with regard to Automatic Processing of Personal Data as well as the Convention's Additional Protocol on supervisory authorities and trans-border data flows.

There are no specific laws on data protection. However, the following legislative acts contain data protection provisions:

- Constitution of the Republic of Kazakhstan
- Criminal Code
- Civil Code
- Labour Code
- Law on Banks and Banking Activities
- Law on Informatization

There is currently neither a Data Protection Authority in Kazakhstan nor comprehensive data protection legislation. There will be a provision for the establishment of a Data Protection Authority in the Law on Data Protection that is currently in progress. It is currently unclear when this law will be approved. On October 10, 2006 the President of Kazakhstan signed a decree that approved the Concept of Information Security. The Concept provides general information on possible threats to information security of the country and will serve as a reference point for all Kazakhstan further developments related to information security. It is expected that a Law on Data Protection (or Law on Information Security) will be adopted based on this concept paper.
